Authorization for the Sale of Hametz Pesah 5785

I, the undersigned, do hereby fully empower, constitute and appoint RABBI DAVID ELMALEH my true and lawful attorney to act in my place and stead, for me and in my name and on my behalf to sell all **Hametz** owned and possessed by me (knowingly or unknowingly) as stated in the Torah and interpreted by Rabbinic Law. [This may include Hametz (Hametz is any product that contains ingredients from the five major grains: wheat, barley, rye, oats, and spelt that is moistened by a period of time defined by Jewish Law), such as baked goods, flour, cereals, bread crumbs, liquors, beer and other alcoholic beverages, animal food, and also including products that may contain Hametz and all toiletries and pharmaceuticals that are edible and even any questionable Hametz.] This also includes Hametz that tends to harden and adhere to surfaces of cooking or other eating utensils but not including the utensils themselves. This excludes any Hametz that I will burn or otherwise dispose of before 12:05 pm Shabbat, April 12, 2025.

RABBI DAVID ELMALEH has the full authority and power as above given to sell said Hametz and to lease said place or places wherein said Hametz may be found upon such terms and upon such conditions as he in his absolute discretion shall deem fit and proper.

RABBI DAVID ELMALEH has the full power and authority to assign or appoint a substitute or substitutes to act in his place and stead with all the same powers and authority that I have invested in him, and I do hereby ratify and confirm all that my said attorney, or his substitute or substitutes, shall lawfully do or cause to be done by virtue of these presents.

The above given power shall be in conformity with all Torah, Rabbinical regulations and laws and also in accordance with the laws of the state of Florida and the United States.
